Host responsibility this festive season

I'm pleased to share some exciting news about improvements we are making to how we keep you informed. I'd like to introduce our monthly Connect feature in the Messenger.

Putting on a holiday celebration for your employees can be a great way to say thank you for a busy year and an opportunity for workmates to relax and celebrate together while building and strengthening relationships.

If you choose to include alcohol at your workplace function, make sure it's supplied in a way that fits with your workplace alcohol policy and have measures in place to help people stay safe and enjoy themselves.

If your event is held at another venue, you or the venue may need a special licence. You can check this with the alcohol licencing team at Buller District Council.

SAFELY is a simple way to remember the key components of host responsibility:

- S Use responsible alcohol Service
- A Provide Alternatives to alcohol
- F Offer substantial Food
- E Prevent Excess consumption
- L Organise Lifts/rides home
- Y Look after Young people
- Clearly outline your expectations upfront. It is helpful to have drinks served, rather than providing a 'free for all' situation.
- Always provide low and non-alcoholic options and have water freely available.
- Have plenty of food on offer from the start of the event and right throughout.

- Don't encourage/promote heavy or excessive drinking.
- Make sure safe transport options are in place to get everyone home safely.
- Take extra care if you have young staff members in attendance or on bar duty.
- It is illegal to supply alcohol to anyone under 18 years without express consent of a parent. You could be fined \$2,000 if you don't follow the law.

Remember, as a host, you set the tone for the event and behaviours in relation to alcohol and must make sure your event complies with the Sale and Supply of Alcohol Act 2012.

## Get ready for a Kiwi summer of sport at Buller District Libraries

The Buller District Libraries Summer Reading Programme is just around the corner. This year's theme is 'A Kiwi Summer of Sport' and will include active themed challenges, activities and games at the library, along with sporting story times.

Kids can choose any reading material to read for five days a week during January and they'll qualify for our major prizes and the chance to win an iPad! The programme is a great way to keep Buller students' minds active during the holiday period. Entries are limited to 100 young readers from 5-15 years old, so make sure you get in fast. As summer approaches, Council staff will be checking pools across the district to ensure compliance with the Building Code clause F9. The objective of this clause is to prevent injury or death to young children as a result of them gaining unsupervised access to residential pools.

Property owners listed on the current pool register will be notified that an inspector will visit to assess the pool barrier and/or cover for small, heated pools, confirming adherence to the Building Code requirements under F9 – Acceptable Solutions for Clause F9 – Means of restricting access to residential pools. This is a reminder for pool owners

to please ensure your pool barrier and/or cover for small, heated pools meets the required safety standards. Failure to do so may result in additional costs for repairs and additional inspections.

# Water

### Water supplies

Council would like to remind **all consumers** to flush their taps by letting about a mugful of water run through in the morning, prior to use.

This applies to all supplies including rainwater. Visit Council's website 'water - plumbosolvency' for details. There are different levels of water treatment in Buller.

The **Cape Foulwind** water supply (Wilsons Lead Rd and Bulls Rd) is for stock use only and is not intended for human consumption.

A permanent boil water notice applies for Little Wanganui Subdivision, Mōkihinui, Ngakawau/Hector, South Granity and Waimangaroa.

#### Stormwater

Please consider stormwater and wastewater separation. Stormwater that enters the sewer must be treated as sewerage. This can cause sewer capacity problems during prolonged and heavy rain.

The majority of the stormwater is discharged untreated into the district's rivers. Please consider this when discharging fluids into the stormwater system. If you wouldn't want to swim in it, it shouldn't be going into the stormwater and needs to be disposed of as wastewater.

### Wastewater

Please don't flush paper towels or any wipes, including those labelled as flushable, down the toilet.

People who have a connection to the **Orowaiti** sewerage scheme are reminded that they should no longer be using septic tanks and should be connected to the reticulation.
