We refer to your official information request dated 27 June 2024, your request, and our response in red, are as follows:

Can you advise, what is the correct figure/ the full amount of money given to the Mokihinui Lyell Backcountry Trust by BDC, since the MLBT's inception (constructing the 'Old Ghost Road", linking the existing historic Mokihinu pack track and the historic Lyell dray road, and overlaying both historic tracks.

Since the official opening of the Old Ghost Road (OGR) on 15 December 2015, Buller District Council has supported the Mokihinui Lyell Backcountry Trust (the Trust) with \$271,500 NZD between the financial years 2015/2016 and 2023/2024.

During this time, Council allocated \$30,000 NZD per financial year to support the

Trust with maintaining the OGR as part of the Annual Plan/Long-Term Plan. In October 2016, Council granted the Trust an extra \$1,500 NZD from its Community Grants as part of the first Community Grants round. All figures are zero GST-rated.
